Curriculum Feedback from Students







Graphical Result of the feedback from students










Interpretations

- The curriculum enhances competencies of the students: The overwhelming majority (86%) highly agree that the curriculum enhances student competencies, with an additional 10% agreeing and 4% moderately agreeing. This indicates strong approval of the curriculum's effectiveness in building competencies.
- Syllabus and teaching methods were appropriate to students' requirements: Most respondents (83%) highly agree that the syllabus and teaching methods are appropriate, with another 15% agreeing and 2% moderately agreeing. This suggests that the teaching methods and syllabus are well-aligned with student needs.
- Syllabus includes provision for employability skills and soft skills: A large majority (82%) highly agree that the syllabus includes provisions for employability and soft skills, with 16% agreeing and 2% moderately agreeing. This indicates a strong recognition of the curriculum's emphasis on employability skills.
- 4. **Relevance and appropriateness of the units prescribed in the curriculum**: Most respondents (85%) highly agree that the units in the curriculum are relevant and appropriate, with 13% agreeing and only 1% moderately agreeing or disagreeing. This shows strong support for the relevance of the curriculum.
- Appropriate allocation of credits to the courses: The majority (89%) highly agree with the allocation of credits, with 10% agreeing and only 1% moderately agreeing. This indicates that credit allocation is well-received and considered appropriate.

- 6. **Regular updating of the syllabus to meet their needs**: A significant majority (82%) highly agree that the syllabus is regularly updated, with 14% agreeing and 4% moderately agreeing. This suggests satisfaction with the curriculum's responsiveness to changing needs.
- 7. The size of the syllabus in terms of load on the students: While 80% highly agree and 10% agree that the syllabus size is appropriate, there are some concerns with 6% moderately agreeing and 4% disagreeing. This indicates general satisfaction but highlights a need to address workload concerns for a minority.
- 8. **Appropriate evaluation scheme designed for each course**: A majority (80%) highly agree and 11% agree that the evaluation scheme is appropriate, although 9% moderately agree. This indicates overall satisfaction but suggests room for improvement in the evaluation schemes.
- 9. Appropriate course objective or programme objective: Most respondents (83%) highly agree that the course objectives are appropriate, with additional agreement from 10%. However, 5% moderately agree and 2% disagree, suggesting minor concerns about course objectives alignment.
- 10. **Better institutional process for implementation of the curriculum**: A strong majority (83%) highly agree that the institutional process for curriculum implementation is good, with additional agreement from 13%. However, 4% moderately agree, indicating minor room for process improvement.
- 11. Syllabus provides constructive suggestions for the multifarious enhancement of the curriculum: A significant majority (83%) highly agree that the syllabus provides constructive suggestions for enhancement, with 10% agreeing. However, 5% moderately agree and 2% disagree, suggesting that while most see value in the suggestions, there is some room for enhancing their effectiveness.
