reinvention and recovering the limitless potential of our fragile resources of mankind buried back in the history helps to delineate the heady mix of our prospective investment namely heritage to a de-feasible basis. It studies the story of man's past through material remains. It is a holistic discipline which gives a comprehensive understanding on the complexities in human cultures and societies. It facilitates the conversion and safeguarding of historical monuments and sites and generates a detailed understanding of the complexities in human behavior across the time. Extensive studies in to the archeological heritage of Kerala commenced during the colonial period. The Malabar archaeology developed under the British administration under the then Madras presidency. The Travancore archaeology and the Cochin archaeology developed under the princely states of Travancore and Cochin respectively. The present Kerala state was formed on 1st November 1956, including the then British Malabar, Cochin and Travancore. Hence the department of archaeology in Kerala with the states priority to explore the heritage and conserve it with full proof formulations started since its formation. This paper is an attempt to unravel the history of the genesis and growth of archaeology, in the context of the increasing importance attached to archaeology as an emerging area of study in Kerala.
